

## **American Legion Post 60**

Minutes of the General Meeting July 13, 2011

Post Commander Keithly called the meeting to order at 1855 hours. The following officers were present: Post Commander Keithly, 1<sup>st</sup> vice Commander John Pearson, 2<sup>nd</sup> vice Commander John Dickey, Financial Officer Tim O'Leary, Adjutant Terry O'Keeffe, and Sgt. at Arms Ed Bulgin, There were 16 members in attendance.

### **Adjutant Report**

Adjutant O'Keeffe reported that there are currently 164 Post 60 members. The 2012 dues are payable. Renewal is now available on-line for the first time. One of Post 60's members made use of the new service so far.

1<sup>st</sup> vice Commander Pearson reposted he was contacted by the Department SAL Adjutant with reference to the 2012 SAL membership data cards. John said the cards would be sent to him.

Commander Keithly thanked the Post members who helped direct the parking at KWP on the 9<sup>th</sup> and 10<sup>th</sup> of July.

Commander Keithly also thanked the members of the Post that participated in the 4<sup>th</sup> of July parade for a job well done.

### **New Business**

There was a motion by Archie Banbury, seconded by Ed Bulgin appoint John Dickey to the office of 2<sup>nd</sup> vice Commander. The motion passed by unanimous vote.

Past Commander Jack Knoblock swore in John Dickey to the office of 2<sup>nd</sup> vice Commander and Tim O'Leary to the office of Financial Officer.

Jim Eavenson reported on his recent experience as delegate to the Department Annual Convention in Twin Falls.

Joe Posluszny gave an update on the upcoming 4 Summit Bike Challenge and the Cascade Air Show. Prepping will begin on Monday the 25<sup>th</sup> at 10 AM. Those involved should bring their own Knives. 50 cases of ribs need to be trimmed, seasoned and started cooking. Coolers are needed to pack and ice down the ribs. The work will be done at the Post from Monday to Friday. There will be no Friday Night social the night of the 29<sup>th</sup> of July. The meal will be served on Saturday the 30 from 1:30 until 4:30 PM. Clean-up will be from 5:30 until 6:30 PM. There are approximately 400 riders signed up for the event at this time. The meal will be open to the public from the beginning of serving.

The Cascade Air Show is Saturday August 6<sup>th</sup>. There will be a dedication of a veteran memorial at KWP at 10 AM. There are two locations where BBQ hamburgers, Hot Dogs, coleslaw and cookies will be prepared and served over two shifts. The legion is the sole provider of the food.

Post Commander Keithly said we would need a detail commander, 7 man rifle team, bugler and Chaplain for the dedication ceremony.

The annual picnic was discussed and will take place at the Post on the 10<sup>th</sup> of August at 6 PM. The post will supply the steak and members will supply potluck accompaniment.

Mayday, the 25<sup>th</sup> Army Band saxophone quintet has volunteered to play at the American Legion Post on the 22<sup>nd</sup> of July at the Friday night social.

The Hospital Foundation Golf Tournament is coming up on August 27<sup>th</sup>. There is no sign up yet, but there are at least 4 members interested in playing.

There being no further business to conduct, the meeting was adjourned at 2010 hours.
